Boomalli is dedicated to supporting and promoting artists from NSW Aboriginal language groups. Boomalli provides a safe space for our artists to exhibit, work and tell their stories through their art.

## Excerpts from the Rules of Boomalli Aboriginal Artists Co-operative Ltd:

#### 9. Objects

The objects of the co-operative shall be:

- 1.(a) To provide an Aboriginal Art Gallery for the display of Aboriginal Art and to provide
- 2. exhibition space and support for Aboriginal and Torres Strait Islander artists.
- 3.(b) To promote Aboriginal culture and independence through all visual art mediums.
- 4.(c) To promote the teaching of arts and for self management and self determination.

#### 20. Qualifications for Membership

- 1.(a) A person is not qualified to be admitted to membership of the co-operative unless the board has reasonable grounds for believing that the person will be an active member under Rule 18;
- 2.(b) Every member shall be of Aboriginal or Torres Strait Islander descent and be accepted as Aboriginal or Torres Strait Islander by the Aboriginal community in the local area;
- 3.(c) Every member shall hold at least five shares;
- 4.(d) Every member shall pay an annual membership subscription of \$22.00. The membership
- 5. fee is to be paid by 30 September of each year;
- 6.(e) EXCLUDED NOT REGISTERED
- 7.(f) All members must be active members of the co-operative.

#### 18. Active Membership Provision

- 1.(a) The promotion and preservation of Aboriginal arts is a primary activity of the co-operative; and
- 2.(b) a member shall during the previous twelve months have:
  - a.(i) kept a current curriculum vitae with the co-operative;
  - b.(ii) displayed a work of art in the co-operative's gallery, and
  - c.(iii) contributed a work of art free to the co-operative, to be used for the purposes of
  - d. raising funds at an annual sale, in order to continue the work of the co-operative.
  - e. The funds so raised shall be used at the discretion of the board, and
  - f.(iv) provided six completed works of art of exhibition standard to the society to provide
  - g.a stock for exhibitions and sales arranged by or through the co-operative; in order to establish active membership of the co-operative.
